#### **Tournaments**

The November 15-16 Open Sectional was very successful:

- There were 20 tables in Open and 11 in the NLM for the morning session.
- The afternoon session had 17 tables in the Open and 9 in the NLM.
- Thirty-two teams competed in Sunday's Swiss Teams.

In spite of having to hire an ACBL director with his per diem and hotel costs, it is estimated that the unit netted \$3,791.09. This number will be finalized when the proceeds are received from ACBL.

• If an Open Sectional is held next year, it needs an assistant director to support the Tournament Director.

It takes a village—in this case a unit—to successfully run such an event.

- Special thanks to Casey who designed and managed reservations and room setup. Although the online reservation was frustrating to some members who are not tech savvy, it did ensure we did not exceed capacity. It also helped that Rita blocked those dates on the club's online reservation system. Due to the heavy rain, we had multiple cancellations so the entire wait list was able to play.
- Melinda Wilson was dedicated in finding partners to satisfy any request, no easy task.

Various issues were debriefed and need to be resolved prior to next year's tournament. Casey lead the discussion with items from his post mortem list:

- Establish a time for No Shows to lose their guaranteed reservation.
- Establish an absolute upper table count limit. 35?
- Provide 2 caddies for the Swiss team event.
- Provide a working PA system that can be heard in all rooms.
- Evaluate Signup Genius for partnership requests.
- Delegate the shopping for food from the Tournament Chair to others.
- Consider increasing card fees from \$14/session to \$15.

#### **Long Beach Bridge Center**

Chuck reported:

- The ice machine is broken and is out for service.

- The GNT finals will be held at the club on Sunday, May 31<sup>st</sup>. The district will pay rent of \$200/day.

Joey reported that the club earned \$640 from the unit-sponsored STaC games this year versus \$220 from the district-sponsored ones. She plans to schedule 3-4 unit-sponsored STaC's next year.

**Leisure World Report:** Glenn reported that Leisure World's table counts are up. With Joey's support, their directors are now using "+Hacks" to upgrade any qualifying game for ACBL's extra points.
